

## **Director's Note**



National Initiative against Organized Crime (NIOC) is the firstever initiative in Pakistan launched by a group of committed professionals and experts with law enforcement, media and other public service backgrounds. NIOC aims to build community resilience and influence public policy to combat organized crime. Initially launched as a pilot project with effect from November 1, 2019, it aimed to jump start not only the discussion around transnational organized crime in Pakistan, but also to facilitate the work being done by various stakeholders of both the federal and provincial governments.

With a complex governance structure having multiple layers of stakeholders, the criminal justice system and law enforcement apparatus require better coordination and capacity building. NIOC is trying to identify the gaps and suggest improvements in the system.

NIOC is a three- tier organization: It has six advisory board members, four directorate staff, three consultants and eight subject experts.

Team NIOC believes in going together on a TRIP:

- > T stands for trust and transparency.
- **R** stands for reputation which is gained from trust.
- > I stand for innovation.
- **P** stands for progress and pursuit of excellence.

There are some key law enforcement institutions dealing with Organized Crime at the national level: Federal Investigation Agency (FIA), National Counter Terrorism Authority (NACTA) and Ministry of Narcotics Control/Anti-Narcotics Force (ANF). NIOC not only collaborated with these organizations but also provided them valuable inputs. It has also gained traction and credibility with policy community. Secondly, the research studies and policy briefs that the NIOC has produced and disseminated have generated a debate and discussion amongst various stakeholders on the issue of Organized Crime. Thirdly, the NIOC website is providing credible source of information for civil society, academia, students, researchers and relevant stakeholders.

We are determined to make a difference in pursuit of our mission to forge an organized response to organized crime in Pakistan.

The following are the main features of NIOC work undertaken from November 2019 to December 2020.

## November 2019

The first meeting of the advisory board of the National Initiative against Organized Crime (NIOC) was held on November 9, 2019, in Islamabad. Following decisions were taken:

- Orientation of new briefing on its aims and linked measures.
- Some key decisions were taken to delegate roles and responsibilities in terms of preparing strategy papers, and a monthly newsletter, holding a stakeholders' roundtable, and developing a network of experts.
- Four organized crime categories approved to develop nation-wide strategies: terror financing, drug trafficking, human trafficking, and cyber-crimes.

After board meeting, the first stakeholders' roundtable conference was held on November 22, 2019. Representatives of different departments and organizations not only appreciated the NIOC but also promised to fully help and support its initiatives as follows:

- Consensus on developing modalities for effectively curbing terror financing and linking the discourse to FATF.
- Deliberations on how NIOC could help government's policy on narcotics control, including through learning from world's best practices.
- Progress made for an institutionalised collaboration and cooperation with different related departments and experts.



## December 2019

In the month of December, the second advisory board meeting was held on December 5, 2019 in Islamabad. Following decisions were taken

- Issuance of draft analysis paper on terror financing in December/January 2019
- Issuance of analysis paper on anti-narcotics in December 2019
- NIOC signed a Letter of Engagement with Kashif Noon as a strategist and lead researcher in the NIOC team with clear TORs
- Second Stakeholders' Consultation Meeting would be conducted during January 2020
- NACTA has nominated DIG Shahzada Sultan as a focal person for coordination
  with NIOC. He will be asked to prepare an analysis paper on terror financing in
  which issues like legal mandate, involved stakeholders, FATF conditions would
  be included along with our present standing in this regard.

NIOC issued first monthly November newsletter and disseminated it widely to relevant stakeholders. The newsletters contained updates, alerts and excerpts [from relevant NIOC articles] focusing the four categories of organized crime on the NIOC's mandate: terror financing, drug trafficking, human smuggling and cybercrime.

Director NIOC Tariq Khosa represented NIOC Pakistan at a workshop in Dubai on 8-11 December 2019 that was organized by the National Defence University Washington DC on "Countering Illicit Networks in the Levant and Gulf. "Drugs Trafficking in Pakistan: An Analysis," a policy analysis paper was presented on behalf of NIOC along with power point presentation in a 4-day workshop in Dubai on

Organized Crime. Mr Khosa also discussed with NESA and NDU USA to organize a 2-day workshop in Islamabad from NIOC platform on Organized Crime in 2020.

On invitation of the Global Initiative Against Transnational Organized Crime (GITOC) Director Tariq Khosa participated in a Consultation Meeting in Bangkok on December 13, 2019 on "The Future of Organized Crime". This consultation was one in a series of thematic and regional consultations with GI Network members to explore the current global trends on organized crime. These consultations were to feed into a drafting process for a wide-ranging report on global organized crime trends that the GI-TOC hopes will contribute towards ongoing organized crime discussions at the UN, including for the 2020 Crime Congress and the UNTOC CoP in 2020.

NIOC directorate meeting was held on December 20, 2019 to plan the activities for January 2020.



# **January 2020**

During January 2020, the third NIOC advisory board meeting was held on January 17, 2020 in Islamabad. Following were the salient features of the meeting:

- A monthly December newsletter issued that contained updates, alerts and excerpts of relevant articles in the four categories of organized crime that NIOC was addressing.
- Improvement to NIOC website will be made from international best practices perspective.
- Analysis Paper on Drug Trafficking has been shared with Ministry of Narcotics Control for feedback and would be disseminated before the end of January 2020.
- The analysis paper on terror financing is work in progress. Its draft would be ready by mid-February.
- NIOC is establishing a network, on the lines of GI-TOC, of committed individuals working against organized crime all over the country.
- Member AB Zubair Habib, in collaboration with ANF, was requested to get a survey carried out about the extent of drug abuse among the students of Karachi. This would be an important project for which UNODC's support would be enlisted.
- For better visibility on social media space, Secretary NIOC Mr. Amir Rana was requested to launch NIOC on PIPS Facebook as well as Twitter handle
- Op-Eds to be written on NIOC and its mission in DAWN a leading newspaper of Pakistan
- NACTA will arrange a special briefing/presentation for NIOC on terror financing. Modalities will be worked out soon between NC NACTA and Director NIOC

 Mr. Kashif Noon and Mr. Ali Nekokara will get in touch with FIA focal persons on Human Trafficking and Cyber Crimes and start work on analysis papers in the two categories of organized crimes.

A consultation session with stakeholders was held on January 17, 2020. Director NIOC welcomed senior officers who attended the Consultation Session after the AB Meeting. DG CTF Mr. Muhammad Iqbal and Mr Abbasi from NACTA; ADGs Ahmed Mukarram and Mr. Ehsan Sadiq from FIA; and DDG ANF Mr. Ghulam Qadir They made a significant contribution to the discussions during the consultation session. The following decisions were taken after NIOC presentations on Terror Financing (TF) and Drug Trafficking by Consultant Mr. Kashif Noon:

- NACTA will arrange a special briefing/presentation for NIOC on TF.
   Modalities will be worked out soon between NC NACTA and Director NIOC.
- DDG ANF undertook a feedback by MNC and ANF on NIOC Drug Trafficking Paper.
- TF Presentation will be fine-tuned and shared with NACTA soon.
- Kashif Noon and Mr. Ali Nekokara will get in touch with FIA focal persons on Human Trafficking and Cyber Crimes to start work on analysis papers in the two categories of organized crimes.

President, Director, Secretary and Advisory Board members of NIOC participated in Dialogue Pakistan 2020 held on January 25, 2020 at Hotel Margala, Islamabad. Mr Tariq Parvez-President and Mr Tariq Khosa-Director National Initiative against Organized Crime in Pakistan, and AB member Mr Zahid Hussain, were given an opportunity to speak in a session "Have We won the War against Terrorism". They discussed in detail the challenges faced to Pakistan in terms of organized crimes and especially terror financing.



# February 2020

In the month of February, the fourth advisory board meeting was held on February 7, 2020 in Islamabad. Following were the main points:

- Analysis paper on Drug Trafficking and two policy briefs on Afghan Drug impact on Pakistan and Domestic Drug Abuse Menace were shared with the Joint Secretary Ministry of Narcotics Control for peer review and further feedback
- A drug abuse survey amongst students of Karachi was also to be conducted by CPLC in collaboration with the ANF
- AB approved to hold 2-day International Conference on Organized Crime at Islamabad Club on 21-22 March 2020
- Improved the design and quality of NIOC Brochure
- Redesigned the NIOC website
- Prepared analysis paper on each focus area of the NIOC preferably to be ready by March 15, 2020
- Draft Analysis Paper on Terror Financing issued.

## **March 2020**

During March, the fifth advisory board meeting was held on March 6, 2020. Following were the main points of the meeting

- NIOC distributed its brochure [printed copies] among all the relevant stakeholders including foreign missions, CSOs and think-tanks.
- NIOC Newsletter for February 2020 was reviewed and approved for circulation by PIPS.
- NIOC website was developed and launched to improve outreach of its activities and products (www.nioc.pk). Participants agreed that more professional material would be added to make it purposeful.
- NIOC has established a Network of Experts working in the areas of organized crime. All Advisory Board Members were asked to nominate Experts and Champions of Change from among the civil society for approval by NIOC AB in next meeting to be held on Friday, 3 April 2020.
- A Paper on Drug Trafficking was approved by the AB. It would be sent to GITOC for circulation globally.
- GI-TOC Discussion on fragility and violence was found to be especially useful by advisory board. Kashif Noon, Consultant, was tasked to prepare its summary for discussion during AB Meeting on 3 April 2020
- Finally, draft of the analysis paper on Terror Financing was presented to the AB by Consultant Kashif Noon. Particularly useful discussion was held and feedback and review by DIG Shahzada Sultan of NACTA was appreciated.





Mr Jameel Hussain Junejo finalised the paper on the drug situation in Karachi and shared with AB members for their feedback. Mr Asad Jamal was writing an "Cybercrime analysis paper on legislation and related rules: Recommended way forward." Due to the current coronavirus situation, he will submit the paper in the first week of April. Mr Kashif Noon-Consultant has finalised the papers on terror financing and drug trafficking during the current month but also started to produce first draft of paper on human trafficking.

NIOC directorate had started preparations for the said International Conference. It was decided to postpone



the 1st International Conference on Organized Crime earlier scheduled for 21-22 March. New dates are 13-14 April 2020, subject to relaxation of restrictions imposed by the government on meetings and conferences.

Community outreach plan with Islamabad Police for public awareness about drug abuse among school and college students had to be postponed.

Mr Tariq Khosa released a video message On March 23, 2020 (Pakistan Day) for AB members, partners, directorate staff and civil society about the activities and updates of National Initiative against Organized Crime. The video was titled "We celebrate this because Pakistan Resolution was passed in 1940". Some message highlighted were as follows: "We are facing this crisis of Coronavirus. According to our national motto "Unity, Faith, Discipline," we will certainly as a resilient nation overcome this challenge. Community outreach activities are [continuing to be] suspended, although we are practicing social distancing. However, we are digitally connected and pursuing our research work."



# **April 2020**

In the month of April, the sixth advisory board meeting was held on April 3, 2020 in Islamabad. Some main points were:

- In order to support Global Initiative's Covid Crime Watch, NIOC AB decided to launch Organized Crime and Pandemic Nexus in Pakistan Project. The weekly reviews involve mapping and monitoring of criminal activities in the four categories of OC: terror financing; drug trafficking; human trafficking and cybercrimes. An additional aspect of terrorist incidents was also to be included. Secretary NIOC is tasked to compile a Weekly Update and Analysis that is shared with GI-TOC Resilience Fund in Vienna.
- It was also decided to start a NIOC Blog on related OC developments in April, May and June 2020. Secretary Amir Rana has initiated this effort and apart from AB Members and NIOC Directorate staff, some other prominent opinion-makers have been requested to contribute.
- NIOC AB gave go-ahead to obtain membership/ registration of NGOs Alliance on Crime Prevention and Criminal Justice launched by the UNODC. An annual fee of Euro 60 would be paid. Secretary NIOC Amir Rana has submitted application on behalf of NIOC/PIPS.
- NIOC AB also approved that Director NIOC should seek an extension of two months of May and June 2020 for the Pilot Project completion of mission as COVID-19 had slowed down the activities being undertaken. Main justification for extension was to launch OC and Pandemic Nexus monitoring. Some additional funds were sought from GI-TOC Resilience Fund through a proposal. Approval for extension has been conveyed by GI Resilience Fund.





- Advisory Board welcomed the inclusion of 6th member Ms Samina Ahmed who consented to be part of the National Initiative against Organized Crime in Pakistan. She will formally join on 1 May 2020 and shall participate in next AB Meeting proposed to be held on Friday 8 May 2020.
- NIOC Newsletter for April 2020 was reviewed and approved for circulation.

Paper on "Drug Situation in Karachi" was submitted by researcher Jameel Junejo. It was published on NIOC website and disseminated in print to relevant stakeholders. Kashif Noon submitted the first draft of Analysis Paper on "Human Smuggling and Trafficking". It was shared with DG FIA for input on last five years data as well as the feedback from the agency's expert. Draft analysis Paper on Terror Financing was approved with the suggestion to flag the challenges that the coronavirus pandemic will pose and opportunities that may exist for the militant organizations to exploit the situation in the garb of charity donations that could be diverted to criminal activities. Consultant Kashif Noon was tasked to prepare a shorter policy brief on TF based on



the Analysis Paper. Paper on "Cyber Crime Legislation" could not be submitted by Barrister Asad Jamal during April as he fell ill. It would be finalized in May and shall be shared with all AB Members.

NIOC membership/ registration in "NGOs Alliance on Crime Prevention and Criminal Justice" was successfully managed.

Advisory board approved to postpone the planned International Conference on Organized Crime, earlier planned to be held in Islamabad on 13-14 April, due to travel restrictions. It was decided that the conference may be convened in June

2020, subject to COVID-19 situation. In case situation does not improve, it was agreed that National Strategy against Organized Crime may be disseminated through printed report or through a few podcasts.

NIOC director and advisory board members regularly write blogs related to organized crime developments and Covid-19 pandemic for the website.

Corona Crime Watch Pakistan, a weekly review of the situation of the Covid-19 pandemic and its interface with the organized crime, was continually developed and disseminated through the NIOC website. The weekly monitor worked as a civil society initiative to support the institutional and community responses. It is based on the information collected from open sources, mainly the mainstream media reports, Urdu and English as well as information collected from various experts associated with the project.



# **May 2020**

In May 2020, the NIOC seventh advisory board meeting was held on May 15, 2020 in Islamabad. Following were the main points:

- Director Tariq Khosa introduced new Advisory Board Member Ms Samina Ahmed, and Consultant Ammar Jaffri. Ms Ahmed of Brussels-based International Crisis Group is an expert on security and criminal justice issues. She is Director of ICG and is currently in Islamabad. Mr Jaffri is former Additional Director General of the Federal Investigation Agency whose expertise in technology is well established.
- Mr Tariq Parvez, President NIOC AB, welcome both new team members of NIOC Pakistan.
- Director informed the Board about extension of NIOC Pilot Project for two months of May and June 2020 due to Covid-19 challenges that affected the targets that had to be achieved during the first six months of the project approved and supported by Global Initiative Resilience Fund. He specially appreciated and thanked GI Resilience Fund Manager Ian Tennant and his team in Vienna for their generous and wholehearted support to NIOC Pakistan.
- Secretary NIOC Amir Rana also informed the Board that a professional editor
  has been engaged to convert NIOC Analysis Papers on Terror Financing, Drug
  Trafficking, Human Smuggling and Cyber Crimes into Policy Briefs. This task
  would be completed before 07 June 2020.
- Another proposal was discussed in the context of holding Roundtables on a category of OC that NIOC is focusing on like terrorism, drug trafficking and

cyber-crimes. This can be a fortnightly feature to be hosted by an AB Member and participation by 3 or 4 experts at the national or international level. Consultant Ammar Jaffri will organize these round tables.

NIOC will come up with a short paper on terrorism in Pakistan during Covid-19 outbreak, especially in the context of conflict zone of Afghanistan and recent peace accord between the Taliban and the US. Amir Rana, Secretary NIOC would prepare this paper and take the help of AB Members and can seek assistance of any other professional of his choice to put together the paper on terrorism before 15 June 2020.

Mr Ammar Jaffri, Consultant on Communications Strategy, was tasked to come up with a Concept Paper on "Engaging the Civil Society to Strengthen Community Resilience against Organized Crime". He will submit this concept paper before 31 May 2020.

NIOC Directorate will come up with a National Strategy against Organized Crime in Pakistan by later in 2020. Draft will be prepared by Consultant Kashif Noon. It will cover four categories of OC: terror financing, drug trafficking, human smuggling and cybercrimes.

National Stakeholders' Conference will be held during the third or last week of June provided Islamabad Club, the proposed venue of the moot, is opened as part of government policy of lockdowns during the coronavirus outbreak. Further modalities in this regard will be finalized in the 8th AB Meeting to be held on Friday 5 June 2020.

NIOC directorate started publishing blogs regularly related to organized crime developments and Covid-19 pandemic on website.

NIOC is currently issuing a weekly Corona Crime Watch review as a result of decision taken during last AB Meeting on 3 April. Secretary NIOC Amir Rana is spearheading this important initiative, which has been appreciated by GI Resilience Fund as well as different international stakeholders who are recipients of the weekly review issued every Saturday. AB Members gave useful suggestions to add value to this weekly review.

NIOC Directorate meeting held through video link on 23 May 2020 to follow up some decisions taken during advisory board meeting on May 15, 2020.





## **June 2020**

In the month of June 2020, the eighth advisory board meeting was held on June 5, 2020 in Islamabad. Following were the main points of the meeting

- The Minutes of the previous [7th] Advisory Board meeting were approved.
- Director NIOC also sought proposals from advisory board members about the performance of NIOC since its inception on 01 November 2019. While some suggestions were made, the Members undertook to convey those through emails to the Director.
- President AB Tariq Parvez informed the members about a USIP Initiative on Police Reforms Follow-up in Pakistan. He wanted collaboration from NIOC for this initiative. Since justice sector reforms would be part of the expanded mandate of NIOC from July, the members assured him of support.
- Due to his official engagements, advisory board member Fiaz Toru asked not to be included in the Advisory Board from July 2020. Director NIOC informed that Jawaid Akhtar, former deputy chief constable of the West Yorkshire Police UK had agreed to be a Member of NIOC AB. He has vast experience in dealing with organized crime in the UK.
- Another area of focus was criminal justice reforms in the context of OC.
  Director NIOC informed that Justice Asif Saeed Khosa, former Chief Justice of

Policy briefs on "Drug Trafficking in Karachi," "Drug Situation in Pakistan" and
"Human Smuggling and Trafficking in Pakistan" were approved for further
dissemination and publication; these have already been edited. Policy briefs on
"Terror Financing" and "Cyber Crimes" are in editing process and would be
finalized by end June.

NIOC's Plan of Activities for July-December 2020 was discussed. It was agreed to expand the scope of NIOC mandate to include the full spectrum of terrorism as it poses a major threat to Pakistan through Organized Criminal Networks. Emphasis will be placed on CT and CVE strategies.

Secretary Amir Rana presented outline of a policy brief on "Terrorism and Covid-19." After a discussion about some latest developments in the context of resurgence of militancy, the outline was accordingly approved. Amir Rana will finalize the policy brief in the last week of June. Mr Ammar Jaffri, Consultant on Communications Strategy, presented an outline of "Community Outreach Strategy" that would be put in place in the second half of 2020. He was asked to finalize the same by 30th of June. Consultant Kashif Noon presented an outline of a draft "National Strategy against Organized Crime." He was asked to submit the first draft by 30th of June. OC National Strategy will be approved in the last week of June before completion of NIOC Pilot Project phase.

NIOC organized first Roundtable on Terrorism and Covid-19 on 4 June 2020. Director NIOC Tariq Khosa moderated the discussion. Three eminent panellists Zahid Hussain, Samina Ahmed and Amir Rana carried out a very professional discussion. Director NIOC presented a six-point national agenda at the end of the discussion by recommending the way forward for Pakistan.

NIOC organized second roundtable on "Cyber Harassment under the shadow of corona: incidence, control and punishment" on 18 June 2020. Advisory board member Fasi Zaka moderated the discussion. Three renowned panellists Farieha Aziz, Ammar Jafri and Nighat Dad carried out a very fruitful conversation. Mr Ehsan Sadiq Additional Director General FIA participated in the discussion as a guest of honour and gave his expert opinion.

NIOC arranged third roundtable on "Advocacy for Police Reform" on 22 June 2020. Advisory board member Samina Ahmed moderated the discussion. Justice Asif Saeed Khan Khosa, Former Chief Justice of Pakistan was the Guest of Honour. Three well-known panellists Tariq Parvez, Zahid Hussain and Hassan Abbas raised different sets of questions with Justice Khosa. All interconnected very well with their pertinent observations.

National Stakeholders' Conference on organized crimes was postponed due to COVID-19 situation. Further course of action will be discussed in the next AB Meeting to be held on 10 July 2020.

NIOC was issuing Corona Crime Watch review on every Saturday. Secretary NIOC Amir Rana spearheaded this important initiative, which was appreciated by international stakeholders who were recipients of the weekly review.

Justice Asif Saeed Khosa, former Chief Justice of the Supreme Court of Pakistan, joined NIOC as Senior Justice Sector Advisor in an honorary capacity.

Policy brief "Drug Trafficking in Pakistan" was published on the website as well as disseminated to stakeholders in print. Policy brief "Strategic Policy Options to curb Terrorism Financing in Pakistan" was published on the NIOC website and disseminated to relevant stakeholders in print. Policy brief on "Human smuggling and Trafficking in Pakistan" was published on the NIOC website and widely disseminated to relevant stakeholders in print form. A policy brief on "Terrorism and Covid-19" by Amir Rana was approved by AB. Consultant Kashif Noon completed the first draft of "National Strategy against Organized Crime in Pakistan". NIOC Directorate meeting held through video link on 25 May 2020 to follow up end of June activities.







## **July 2020**

During July 2020, the nineth advisory board meeting was held on July 10, 2020 in Islamabad. Following were the main points of the meeting:

- The Minutes of the previous [8th] Advisory Board meeting were approved.
- Director NIOC welcomed and introduced Jawaid Akhtar, new AB Member. Jawaid, born in Pakistan, moved to the UK, studied there and joined West Yorkshire Police, 4th largest police force of the UK. He rose to Number 2 position as Deputy Chief Constable before his retirement. He has expertise in the area of Organized Crime. Jawaid, in his introductory remarks narrated his experience of working with Police Services of Pakistan and assured of his meaningful contribution to promote the mandate of NIOC against transnational organized crimes.
- Director NIOC then introduced Ian Tennant, Manager Global Initiative Resilience Fund whom he met in December 2019 in Bangkok at a GI-TOC regional meeting. Ian, originally from the UK, is based in Vienna to oversee and coordinate the initiatives launched by GI-Resilience Fund in different countries from 2019. NIOC was launched in November 2019 as a pilot project, initially for six months and was later extended till June 2020 due to Covid-19 and its adverse impact on the target completion. The Project had now entered Phase-2 of six months from July to December 2020. Director Khosa thanked the GIRF management for the trust reposed and continued support for the cause of building community resilience against OC in Pakistan.



- Ian Tennant, in his remarks, expressed his pleasure at joining the AB Meeting and being introduced to all the NIOC Members. He informed that GI Resilience Fund was launched by GI-TOC in May 2019 and now for more than a year it had launched projects and initiatives in 17 countries. He described the National Initiative against Organized Crime in Pakistan as GI Resilience Fund's flagship initiative that in a short span of time had earned national and global recognition. Responding to Director NIOC's remark of a few professionals in Pakistan making a 'humble' effort to make a difference, he responded that the efforts being made by NIOC can make great contributions. On account of his prior commitment, Ian sought leave by wishing all the NIOC members success in their endeavours.
- Director NIOC took up agenda items of the Board Meeting. He apprised the
  meeting that final draft of the policy brief on "Terrorism during Covid-19 in
  Pakistan" had been circulated to all AB members for final review before
  publication. Useful discussion followed with inputs from Zahid Hussain, Samina
  Ahmed, Zubair Habib and President AB Tariq Parvez. It was agreed that PB on
  Terrorism would be finalised within a week so that it could be released before
  end of July 2020.
- As part of Advocacy and Community Outreach Plan, NIOC has been holding Roundtable Conferences and Webinars since June 2020. Three Roundtables were held on June 4, June 18 and June 22 on Terrorism during Covid-19, Cyber Harassment during Coronavirus Pandemic and Advocacy for Police Reform Initiative Launch. During July 2020, three Roundtables on Advocacy for Police Reform were held on 2, 9 and 23 July. The Advisory Board endorsed NIOC's plan for Roundtables/Webinars as part of Advocacy and Community Outreach Strategy to be followed during the second half of year 2020.
- Manager Administration NIOC was asked to expand and organise the Mailing List for dissemination of NIOC publications.
- Director NIOC raised the proposal to identify Champions of Change from amongst the civil society organisations, legislators, media and other sectors so

that they can be motivated to pursue objectives against OC Networks. GI-TOC Network includes individuals serving in various government institutions as well. NIOC AB will deliberate to include some motivated officials who are serving in various organizations combating organized crime in Pakistan.


 Director NIOC also raised the avenue of collaboration at both national and international levels by building partners for concerted efforts against the menace of OC. NIOC has already become a Member of UNODC-steered Alliance of NGOs working against OC. 

In August 2020, the tenth advisory board meeting was held on August 07, 2020 in Islamabad. Following were the main points of the meeting:


- The Minutes of the previous [9th] Advisory Board meeting were approved.





- The Minutes of the previous [10th] Advisory Board meeting were approved.
- Director NIOC presented the outline of a finding proposal, which NIOC prepared in line with the ToR's provided by the British High Commission to conduct a series of webinars on countering extremism between October 2020 and February 2021. Proposal was titled as Combating Extremism through Constructive Engagement (CE through CE). All NIOC AB members supported the proposal and agreed to be moderators, hosts and panellists for the proposed webinars
- Consultant Kashif Noon was asked to finalize the write-up on Uzair Baloch saga showing crime-politics nexus as a case study before the end of September 2020.



- The Minutes of the previous [11th] Advisory Board meeting were approved.
- Director NIOC presented the agenda of the meeting. He informed the members that Saroop Ijaz, a reputed lawyer had agreed to be part of the NIOC team as a legal expert. The AB members were very pleased to know about this development and welcomed Saroop Ijaz's inclusion in NIOC team of professionals.

# November 2020

During November 2020, the thirteen advisory board meeting was held on November 06, 2020 in Islamabad. Following were the main points of the meeting:

- The Minutes of the previous [12th] Advisory Board meeting were approved.
- Director NIOC apprised the meeting about the award of a project on counterextremism (CE) legislation by the British High Commission to NIOC/PIPS. Over the next four months or so, a team finalised by NIOC will undertake a study on "Gaps in CE Legislation and Way Forward." President NIOC AB Tariq Parvez will lead the project.
- An AB member Fasi Zaka put forward a suggestion to organize podcasts based on interviews of selected professionals related with different areas of organized crimes in Pakistan. The Board appreciated and approved the proposal. Director NIOC would work out further modalities of weekly podcasts during Nov-Dec 2020.
- Kashif Noon will complete a case study of "Crime-Politics Nexus in Karachi" and submit the final draft towards end of November 2020.
- Director NIOC informed about continuing collaboration between NIOC and PIPS.
   It would be formalised through establishing an MoU between the two organisations.
- Director NIOC discussed various pros and cons of registering NIOC with the SECP as a non-profit NGO or for-profit CSO. Further modalities are being considered and AB would be kept informed.
- NIOC will start working on a project proposal for funding by GI Resilience Fund for 2021. Director NIOC will work with the concerned directorate staff in

developing the proposal that would be put up for AB's approval in the next meeting to be held on Friday (4th of December 2020).

Director NIOC informed the Board members about the status of the report on "National Strategy against Organized Crime in Pakistan." He shared that NIOC consultant Kashif Noon will draft executive summary and Secretary Amir Rana would get it professionally edited before releasing it to relevant stakeholders for peer review.



In the month of December 2020, the 14th advisory board meeting was held on December 04, 2020 in Islamabad. Following were the main points of the board meeting:

- The Minutes of the previous [13th] Advisory Board meeting were approved.
- Director NIOC, Tariq Khosa gave an overview of the progress of the research study on the BHC Project on Gaps in CE Laws. The project had successfully completed its initial two phases.
- The AB has approved and showed complete satisfaction on the following:
  - NIOC's Proposal for support by GI Resilience Fund for 2021
  - Fasi Zaka would roll out podcasts of various webinars hosted by NIOC during 2020. Eight serials were being finalised.
  - NIOC's collaboration with PIPS would continue in 2021 in accordance with the MoU signed.
- Hassan Sardar, Manager Ops was tasked to come up with NIOC's Annual Report for 2020.

The director NIOC informed to board members that the NIOC's draft National OC Strategy was being peer reviewed by FIA and NACTA. GI-TOC had also recognised the significance of the initiative and agreed to get it reviewed by a few professional international experts. NIOC would launch "National Strategy against Organized Crime in Pakistan" in February 2021.

In the first week of December, November newsletter was released, many worth reading articles were included on the NIOC's mandated areas; like financial crimes, social media rules, drug trafficking and FATF requirements.

It was initially established at 4 Police Stations of Karachi on 31-08-1989 and subsequently the concept of CPLC was institutionalized all over Sindh in 2003. Besides having seven District Offices in Karachi, CPLC's Regional offices have been established at Hyderabad, Shaheed Benazirabad, Mirpurkhas and a District office at Jamshoro. Consequent to the promulgation of The Sindh (Repeal of the Police Act, 1861 and Revival of Police Order, 2002) (Amendment) Act, 2019, passed by the Provincial Assembly of Sindh on 13th June, 2019, the Government of Sindh will establish CPLC throughout the Province.



## **About NIOC**

National Initiative against Organized Crime (NIOC) is the first-ever initiative in Pakistan, which was launched in November 2019 in collaboration with the Global Initiative's Resilience Fund. It is led by a group of committed professionals and experts with law enforcement, media and other public service backgrounds. Through developing an empirical evidence-base and conducting hand-on consultations, NIOC aims to build community resilience and influence public policy to combat organized crime including terror financing, drug trafficking, human trafficking and cybercrime. With a complex governance structure having multiple layers of stakeholders, the criminal justice system and law enforcement apparatus require better coordination and capacity building. NIOC tries to identify the gaps and suggest improvements in the system.
